CAREER SUMMARY

Professor Peter Katjavivi has dedicated his life to the cause of social justice. He played a prominent role in the liberation struggle of Namibia, building international support through diplomatic activity. He used the opportunity of academic research to investigate and write about Namibia's history. He was a member of the country's Constituent Assembly and signatory to the Independence Constitution. He has been involved in nation building, and has been in the forefront of higher education in Namibia, transforming a previously segregated academic institution into a national university with relevant programmes that are increasingly accessible to all Namibians. Appointed Ambassador in 2003, he served in Belgium and subsequently Germany. In 2008 he was appointed Director General of the National Planning Commission in Namibia, in the Office of the President. In 2010 he was appointed as a Member of Parliament and elected as Government Chief Whip. He also leads the Namibian parliamentarians at the Pan

African Parliament. He has highly developed skills in managing diversity, promoting consensus and networking. He has served on the boards of various international bodies and associations, particularly in the educational and developmental spheres. He believes in building bridges, is a good listener and is himself very accessible. He has a particular interest in the strengthening of civil society to enhance good governance and democracy and is active in this field throughout the continent.

The Chief Whip manages the execution of the political programme of the Governing party within the National Assembly and maintains close contact with members of the Party in the Assembly, the Executive, Committee Chairpersons and office bearers. Responsible for arranging business on the Order Paper, subject to the Standing Committee on Rules and Orders; liaising with the Speaker and the Leader of Government Business; and ensuring quorums and proper and regular attendance of committee meetings and the sittings of the Assembly.

AMBASSADORIAL POSTS

Ambassador of the Republic of Namibia to the Federal Republic of Germany 2006-2008

Responsible for promoting and maintaining bilateral relations between Germany and Namibia.

Careful consideration was given to the principles and practice of Namibia's diplomatic endeavours, and, in particular, its emphasis on economic diplomacy as an important tool for promoting Namibian interests abroad.

Continued to deepen the relationship between Germany and Namibia by building economic and business ties, cultural exchanges, and people to people cooperation.

Contributed towards creating avenues through which dialogue between the two countries could be conducted, with particular reference to the question of dealing with past colonial

injustices and the demands of Namibian communities for reparations. The prospects for addressing this issue through established diplomatic channels are now good.

Also served as **Ambassador to the Holy See** and the **Republic of Turkey**. This was the first time Namibia had established diplomatic relations with these two states. In both cases, good foundations were laid for future relations.

Ambassador of the Republic of Namibia to the Kingdom of Belgium, The Netherlands, the Grand Duchy of Luxembourg and the European Union, 2003-2006

Responsible for multilateral and bilateral relations with the Benelux countries, the EU and the World Trade Organisation in Geneva.

Namibia attaches great importance to its relations with the European Communities, and receives significant development assistance from the EU, both at national and regional level. Ambassadorial duties included working closely with various organs of the EU, including its Parliament and the Commission and moving the dialogue on Economic Partnership Agreements (EPAs) forward during the current negotiations with the EU.

Looked for new and innovative ways of promoting links between Namibia and the Benelux countries, by working closely with local people, involved in business, educational and cultural life, including honorary consuls in the three countries concerned.

Organised successful Presidential visit to Luxembourg, May 2006, which culminated in a further commitment of development aid from the Government of Luxembourg to Namibia and pledges from the European Investment Bank to fund Namibian developments in the energy sector.

Relations with the EU are bilateral and multilateral, within the framework of the Cotonou Agreement signed in 2000 and renewed in 2005, between the EU and the African, Caribbean and Pacific member states (ACP).

Active member of the ACP Committee of Ambassadors, which takes key decisions regarding ACP-EU relations, with respect to trade, development issues, etc. Contributed to the work of the ACP and the promotion of the ACP-EU partnership as:

the opening of a Namibian Trade Representation office in Geneva in 2004, which comes under the Embassy in Brussels, and helps to improve communications between the WTO and Namibia. A special training programme for the Southern African region has been developed by the WTO at the University of Namibia.

UNIVERSITY OF NAMIBIA

Founding Vice-Chancellor, University of Namibia, 1992-2003

Responsible for overseeing and guiding the transformation of the former Academy into the first national university in the country, the University of Namibia (UNAM), with a clear vision of meeting the needs and aspirations of an independent Namibia.

This included a complete review of the curriculum in order to provide quality education based on equity. The university's Five-Year Plans dovetailed into the National Development Plans to meet national human resource development needs.

Existing faculties of the university were streamlined. New ones – Law and Agriculture – were introduced. This included transforming and linking the former ethnically based colleges of Agriculture into the new Agriculture Faculty. New programmes in Geology, Engineering, and pre-Medicine were also introduced. Graduate programmes including a Business School were also established and specific centres of learning that provide practical training in the fields of justice, human rights, the public service.

A second university campus was opened at Oshakati, providing access to UNAM courses for the local community. Further centres in other regions of the country have telecommunications links with the UNAM main campus. This model is unique in Southern Africa, representing a smart partnership between the university and the community, and has been hailed as a forward-looking example of an engaged university.

In a country isolated by its colonial experience, the university has become a vital gateway to the international academic community. It is a member of various higher education bodies and is linked through different networks to universities and other educational institutions all over the world.

UNAM has also steadily built a research profile, servicing the Government and private sector across a wide range of social, economic and scientific fields.
