Hon Speaker on Sunday 21 March Namibia become a Mature Democracy as at age 31 a child is normally considered to have become an adult.

While we celebrate this democracy and coming of age there are those who paid a heavy price for our independence, who spearheaded the early revolution and fought bravely for our independence in the German Herero and Nama war of 1904 whose children are treated and regarded as second class citizens in their own land.

It is painful to witness Government total disregard to this 1904 descendants plight since they come back to their Motherland in 1993.

I will therefore ask the Minister of Home Affairs the following questions:

1. Your Ministry has pronounced itself on numerous occassions that you will address the plight of Namibians who reside in Gam, struggle with the issue of obtaining IDENTIFICATION DOCUMENTS especially the IDS for as long as I can remember.

2.However it is clearly evident that 28 years after they come back to their motherland many of them including their kids continue to have difficulties to obtain National IDENTITY DOCUMENTS until this day.

3.Is it a fact or a myth that many of them are being discriminated against by their very own Government, hence many cannot access social welfare benefits that they are entitled to as Citizens without this vital documents?

4. How is it possible that Many Non Namibians who have resideded in Namibia for a period of five years and more can easily become Namibian Citizens through Nationalisation, however descedants of Namibians of the war of 1904 always find it difficult to obtain this documents in their own country till this day?

5.Will you enlighten us and give us figures of how many Namibians returned from Botswana and resettled at Gam in 1993, How many have been issued with IDENTIFICATION DOCUMENTS since that year until now and what is the hold up that the rest cannot be issued with this vital Namibian Documents.



I HEREBY GIVE NOTICE THAT ON THURSDAY 25 MARCH 2021 I WILL ASK THE MINISTER OF INDUSTRALISATION, TRADE AND SMS DEVELOPMENT THE FOLLOWING QUESTIONS:

There seems to be a serious problems confronting the people of Tsumeb especially those that are residing at former TCL hostel, previously owned by Ongopolo Mine that have since closed and now owned by a certain Mr.Groenewaldt.

There are approximately 265 Rooms hosting about 3500 that this people have rented since 2002 in this Hostel block. However since 2017 this people have stopped paying rent to Mr.Groenewaldt because of issues relating to the ownership of this Hostel Block.

On numerous occasions they have asked Mr.Groenewaldt to produce the deed of sale and the deed of transfer and until now he haven't produced any documentary proof to them to show ownership of this hostel block.

It has come to their attention that Mr.Groenewaldt is threatening them with eviction orders, and if one talk about close to 3500 people who have make this former TCL HOSTEL BLOCK THEIR HOME SINCE 2002, I believe there must be serious and immediate intervention by Government to hold this process I believe so.

Having narrated the above scenario I want to ask the Minister the following questions:

1. Are you aware of the ownership of this former TCL Hostel Block and whether there is any proof of ownership in the records of your Ministry in the Name of Mr, Groenewald that he has bought this former hostel blocks from Ongopolo Mine in 2002?

2.Are you aware of the looming evictions process that will make around 3500 residence of this hostel block in Tsumeb homeless, amongst them there are school going kids, grandparents and disabled people who have been residing at that Hostel block since 2002.
