3.0 ANNOUNCEMENT OF THE APPOINTMENT OF A NEW MEMBER TO THE STANDING COMMITTEE ON AUDIT BY THE PRESIDING OFFICER

The Chairperson of the National Council announced in accordance with Rule 168 of the Standing Rules and Orders of the National Council, that Hon. Johannes Kahonzo Sikondo as a new Member would replace the late Hon. Rosa Kunyanda Kavara, and thus shall serve on the National Council Standing Committee on Audit with immediate effect as appointed on Monday, 13 May 2019 by the Steering Committee in terms of Rule 166 of the Standing Rules and Orders.

Before that, he served as Chief of Law Reform at the Law Reform and Development Commission in the Ministry of Justice.

He has also lectured at the University of Namibia and worked as an attorney at the Legal Assistance Centre.

Honourable Members, Ladies and gentlemen

As a representative of the people, the National Council has a vital role to play by articulating the needs of the constituents both here in the Chamber and through its committee activities.

In the 2018-2019 Financial Year, the National Council continued to implement its mandate guided by the principles of continuous improvement of good public governance, poverty eradication, contributing towards an enabling environment for socioeconomic development and employment creation, among others.

In this regard, the National Council reviewed 20 bills that were referred to it by the National Assembly.

Out of those 20 bills, a total of 35 amendments were proposed to several bills, including the Seed and Seed Varieties Bill [Bill Number 1 of 2018]; the Public Enterprises Governance Bill [Bill Number 5 of 2018] and the Basic Education Bill [Bill Number 4 of 2018]. It is worth noting that out of the 35 proposed amendments, 17 were substantive amendments.

Guided by its 2018-2019 Annual Committees Activity Plan, the National Council, through its standing committees carried out several oversight activities.

These ranged from site visits to government capital projects, inspection of MTEF projects, engagement with various ministries and offices involved in socioeconomic development and provision of public services in rural areas, among others.

Although constrained by a limited budget, the National Council standing committees achieved an implementation rate of 76% of the planned activities from which nine reports were tabled and adopted in this House.

By December 2018 a total of 46 recommendations which emanated from National Council standing committee reports were forwarded to 17 OMAs and three regional councils for consideration and/or implementation.

In order to monitor and evaluate the rate of implementation of its recommendations to OMAs, the National Council last year wrote to several OMAs requesting each one to designate a "parliamentary desk officer" to serve as liaison between the National Council and the OMA with regards to implementation of recommendations from oversight activities undertaken by Committees.

So far, 16 OMAs have appointed "parliamentary desk officers" for this purpose.

Ladies and gentlemen

During the period under review, the National Council continued to contribute towards improving good public governance by conducting public hearings with regional and local authorities as part of its oversight role.

Indeed, oversight plays an essential role in enhancing transparency and accountability which are central in improving corporate governance and service delivery within regional and local authorities.

During the 2018-2019 Financial Year, 74 reports were forwarded to the Standing Committee on Public Accounts and the Economy for scrutiny.

As a result, 22 public hearings were held with regional and local authorities who received disclaimer and adverse audit opinions from the Office of the Auditor General.

Furthermore, the Public Accounts and Economy Committee held a stakeholders' consultative meeting from 25 to 29 June 2018 to re-engineer and streamline the process of reviewing Audit General's reports in order to increase efficiency.

The resultant committee report was tabled and adopted in the House during the December 2018 Session.

On another note, the Honourable Members who enrolled for the Certificate in Parliamentary Conduct and Practice with the University of Namibia's Faculty of Law in 2018 have successfully completed the course and attended their graduation ceremony on 12 April 2019.

Congratulations Honourable Members!

For the year ahead, the National Council will continue implementing its Mission and make strides towards realising its Vision, which is "A House of Review that truly represents the interest of the people of Namibia".

We look forward to further engagements with OMAs, the general public, civils society and our international partners as we continue to collaborate and consult in order to implement our constitutional mandate.
