- 3.1 Hon. Shilenga moved a motion without notice: That the proceedings on **Votes 35, 12, 19, 30** and **18** of the *Appropriation Bill* [B.2 2018] be, in accordance with Rule 26 of the Standing Rules and Orders of the National Council, not interrupted if still under consideration at 13:00 hours.
- 3.2 Hon. Kavhura, moved, in terms of Rule 51(1)(i), a motion without notice that the *Microlending Bill* [B.9 2017] be recommitted to the Committee of the Whole Council. Further moved that such recommital be done in accordance with Rule 125 of the Standing Rules and Orders, that provides that a Bill which was previously referred to a Committee, may be recommitted to a Committee, in this instance to the Committee of the Whole Council, as a whole or in part. Therefore, the motion seeks to recommit only

Part 8: General Provisions on page 3, clauses 16, 21, 32, 37, 38, 39 and 42 of the *Microlending Bill*.
