I. Minister of Finance:

That leave be given to introduce a Bill to amend the Income Tax Act 1981 so as to repeal certain existing preferential treatment granted in respect of certain manufacturers and goods, for the purposes of phasing out tax exemptions pertaining to certain traders only; and to provide for incidental matters.

II. Minister of Environment and Tourism:

That leave be given to introduce a Bill to amend the Gaming and Entertainment Control Act, 2018, so as to substitute certain definitions; to amplify the Board's function in relation to responsible gambling awareness programmes; to clarify the source of funding for remuneration or allowances payable to Board members and staff members of the Board; to empower the Minister to prescribe additional licences that may be issued under this Act; to provide for the continuation of gambling business of a licence holder by an executor, trustee, liquidator or curator upon death, insolvency or incapacity of the licence holder; and to provide for incidental matters.
