In view of the fact that the poisonous leaf known as otjikurijoma in Otjiherero and scientifically as Dichapetalum Cymosum causes a number of deaths to cattle in Ohangwena, Oshikoto, Kavango East/West, Omaheke, Otjozondjupa and parts of Zambezi Region.

That a number of virgin lands especially in Omaheke, Otjozondjupa and Kavango remain uninhabited due to the precarious existence of this leaf Dichapetalum Cymosum.

That a national research campaign should be instituted to find a lasting cure and deterrent to the occurrence of this silent calamity.

That this Motion be referred to the Parliamentary Standing Committee on Economics, Natural Resources and Public Administration for investigation.

# II. Mr. Nekundi:

That this Assembly –

- (i) *Discusses* the prevailing situation of foreigners occupying entry positions and other positions of which Namibians have the required qualifications, skills, expertise and experience.
- (ii) Further *discusses* the Immigration Control Act, 1993 (Act. No. 7 of 1993) in relation to the compliance by the employers and enforcement by the State machineries on the employment of foreign nationals in Namibia both in private and public sectors.

After debate, that this Motion be referred to the Parliamentary Standing Committee on Human Resources, Social and Community Development.

# III. Mr. Muharukua:

That this Assembly –

- (i) *Discusses* the scourge of serious and fatal motor vehicle accidents that our public roads have become notorious for.
- (ii) Further, *debates* the possibility of establishing a Central Bureau of Road Surveillance; and the possibility of subjecting all public passenger transport vehicles, and all heavy goods vehicles to a mandatory satellite tracking system, as a measure to curb motor vehicle accidents.
