NOTICE OF A MOTION

Deputy Minister of Safety and Security:

That leave be given to introduce a Bill to amend the Arms and Ammunition Act, 1996, so as to provide for certain definitions; to provide for competence testing and competency certificate; to provide for issuing of copy of defaced, lost or stolen licence, permit or document; to prohibit brokering without licence; to provide for licence to conduct brokering; to provide for registers to be kept, documents to be retained and returns to be rendered by brokers; to provide for inspection of registers of brokers; to prohibit unauthorized repairing, altering and improving of arms; to provide for registration as gunsmith; to provide for issuing of gunsmith certificate; to provide for renewal of gunsmith certificate; to provide for jurisdiction of High Court in respect of offences relating to brokering; to provide for arms free zones; to provide for disposal of arms in case of death, inherited arms and at winding up of business; to provide for the use of arms in theatre and cinema; to provide for conditions in respect of the use, safekeeping and disposal State owned arms; to provide for prohibited conventional arms and ammunition and devices not regarded as arms; and to provide for incidental matters.

I. Mr. Venaani:

That this Assembly –

Discusses the plight of foreign-trained medical doctors who have graduated from universities in countries such as China, Russia and Ukraine.

It is often said that education is the Greatest Equalizer, yet thousands of our youth have not found that Equalizer. I am aware that 240 students who finished the course work, studied on Government grants to the value of N\$125 million. While another 500 more students are expected to graduate, which Government has spent an additional of close to N\$300 million.

The Health Professional Council has for some times now been calling these graduates sub-standard and their demands is to be tested consistently and fairly.

That a Parliamentary Inquiry be set up on these important matters that confronts the future of our youth.

II. Mr. Venaani:

That this Assembly –

Discusses the precarious situation prevailing at the Public Service Medical Aid Scheme (PSEMAS).

According to the IMF report, our country is losing close to N\$900 million yearly, due to corruption and malpractices taking place at the Medical Aid Fund. If this is indeed true, then this is the greatest looting ever in our society.

Therefore, that this Assembly be given a mandate to refer this Motion to a relevant Parliamentary Standing Committee for investigation and report back.
