**MINUTES OF PROCEEDINGS**

**NATIONAL ASSEMBLY**

**THURSDAY, 29 APRIL 2021**

The Assembly met pursuant to the adjournment.

1. The Speaker took the Chair and read the Prayer and Affirmation.
2. The Speaker announced that the Assembly shall stand adjourned today, 29 April 2020 and for the entire month of May until Tuesday, 8 June 2021.

Items on the Order Paper undisposed of shall not lapse, but stand adjourned until June when the Assembly is going to resume.

3. **Mr. Hambyuka moved without notice:**

That the proceedings on Votes 22, 23, 24, 34, 36, 37 and 38 of the *Appropriation Bill* be, in terms of Rule 99(a) of the Standing Rules and Orders, not interrupted if still under consideration at 17:45.

Agreed to.

4. **FIRST ORDER READ:**

Resumption of Committee Stage – *Appropriation Bill* [B. 5 – 2021].

The Minister of Finance moved, seconded by the Minister of Sport, Youth and National Service: That the Assembly now goes into Committee.

Agreed to.

ASSEMBLY IN COMMITTEE:

The Deputy Chairperson of the Whole House Committee stated that when progress was reported yesterday, 28 April 2021, Votes 34, 36, 37 and 38 had been introduced while Votes 16, 17, 19, 21 and 39 had been agreed to. Votes 22, 23 and 24 stood over for discussion.

Vote 22 – Fisheries and Marine Resources: Discussed and agreed to.  
Vote 23 – Works: Agreed to unanimously.  
Vote 24 – Transport: Discussed and agreed to.  
Vote 34 – Public Enterprises: Discussed and agreed to.  
Vote 36 – Gender Equality, Poverty Eradication and Social Welfare: Discussed and agreed to.  
Vote 37 – Agriculture and Land Reform: Discussed and agreed to.  
Vote 38 – Water: Discussed and agreed to.

**IN THE BILL:**

Clause 1 put and agreed to.  
Clause 2 put and agreed to.  
Schedule put and agreed to.  
Title put and agreed to.

**ASSEMBLY RESUMED:**

Bill reported without amendment.

The Minister of Finance moved, seconded by Mr. Mareka: that the Bill be read a Third Time.

Agreed to.

*Appropriation Bill* [B. 5 – 2021] read a Third Time.
