### II. **Deputy Minister of Information and Communication Technology:**

That this Assembly –

*Debates and discusses* the provision of sanitary pads to the Namibian women and girl child through either:

- (i) Imposing a tax exemption on menstrual hygiene products, or
- (ii) Zero-tax – technically subject to taxation but no tax is to be charged or
- (iii) Reduced rate of not less than 3% or as prescribed by our national tax laws.

That this matter be referred to the relevant Parliamentary Standing Committee and/or for the Ministry of Finance to consider bringing an amendment to the tax laws relevant to this nation.

### III. **Dr. Muinjangué:**

That this Assembly –

*Discusses* representation and participation of women in politics in Namibia; whether women are equally represented as their menfolk and if not, for this House to come up and adopt a solution to it.

### IV. **Mr. Mwilima:**

That this Assembly –

*Discusses* the introduction of an insurance cover policy which may assist to fully compensate farmers in terms of damages caused by wildlife to human conflict.

That this Motion be referred to the relevant Parliamentary Standing Committee.
