The government is to be commended also on the achievements it has made on the fight against social inequality in Namibia. As part of the fight against this evil, I commend government for increasing Old Age Pension by an additional N\$100.00 to N\$1,200.00 per month.

The way forward is clear for us, but we know that it will also be bumpy. Our budget should take into bynamic economic trades. consideration of the ever changing challenges.

- Firstly, stronger economic growth will remain unattainable because global growth continues to be flat arising from a rebalancing of the Chinese economy and the normalization of the US monetary policy, while domestically, Namibia was experiencing drought conditions.
- ii. **Secondly**, Weak growth is expected through to 2017/18. This necessitates a 'growth friendly' fiscal consolidation because sound public finances is a prerequisite for national development and will create a solid foundation for long term development.
- iii. **Thirdly,** structural policy implementation is needed to address human capacity issues, the rapid rate of urbanization and to revive the pace of productivity.
- iv. **Fourthly**, the slower growth and weak currency means that Namibia risks a downgrade by ratings agencies to non-investment grade which would increase the cost of borrowing and trigger a sell off from institutional investors.

Before I conclude, allow me to highlight some of the issues that I wish the house should seek clarity and further illumination on;

- i. What would kick start the economy given that the anticipated growth rate would not be achieved?
- ii. What policy issues needed to be addressed to make Namibia a more investor friendly destination because people seems to not feel comfortable to invest here currently?
- iii. Is Namibia able to withstand further economic shocks or had it become complacent and is it competitive enough?
- iv. What is really meant by growth friendly fiscal consolidation?
- v. What measures are in place to address the ballooned civil service and the subsequent unsustainable wage bill?
- vi. Had Ministry of Finance quantified the spending pressures to State Owned Enterprises?

In conclusion, the budget before us is indeed a true representation of our people's need and must therefore be supported and endorsed as a true reflection of what our people really needs. Nonetheless, going forward, the current budget as a tool for government to communicate its fiscal policy stance, it lacks;

- i. **Clear proposals** aimed at addressing the structural deficit such as infrastructures and capital investments.
- ii. Alignment of expenditure with the National Development Plan (NDPs). In this regards, Government should increase capital expenditure to create more jobs rather than spend on consumption expenditure.
- iii. Proposals to curb unauthorized, irregular and wasteful expenditures. State resources to SOEs must be closely monitored and corruptive spending must be stopped.

The 2017/18 budget is set, therefore, it's important for us to make sure that the targets are met by aligning the budget to them. I therefore encourage all members to ensure that this particular budget and the budgets ahead continues to place inclusive and sustainable growth, poverty alleviation, safer and better public infrastructure on top of the agenda of Government.
