BUDGET SPEECH BY HON. P. MOONGO DTA OF NAMIBIA 2014

Mr. Speaker Honourable members welcome back all of you from the recess. I hope this morning you will pay attention. I will divide my speech into three categories: Namibia socio, economically and security.

On the point of security, this house must provide and allocate a budget for the administration of the commission on passion killing of women. It has reached an alarming point. I am requesting all men in Namibia to stop this deadly act forthwith. And I urge Namibian women to control their behaviors, and stop exposing themselves because majority invite trouble themselves.

Mr. Speaker I am proposing a special commission to be established with the prime roll to find the root causes of passion killing of women. This commission must compose in; the retired judge, retired bishop, police, psychologist, forensic expert, traditional leaders, doctor and survivors. Their prime roll is also to coordinate restorative justice and distributive justice to address inequality in the society.

Mr. Speaker Honourable members I hope everyone realize the drought situation will hit Namibia this year again. There will be no enough food for people and the majority will starve. The livestock will die again this year. I appeal to the government to find a remedy and not to propose, farmers to sell their fewer livestock they are left over in 2013.

Mr. Speaker Honourable members allow me to congratulate the Minister of Finance and the staff for a well polished budget of 2014/2015. Though there are a few loopholes, and deliberate omissions. The budget is informative but lacks practical methods.

The first priority motivated by the Minister is to bolster economic growth and to expand Namibia's economy so that Namibia achieve high economic growth rate.

I would like to discuss first some of the omissions and loopholes in the budget. Little has been said about true reconciliation. The insinuation that "We have forgiven, but we will never forget", is still a thorn in a fresh. That means there is still a big gap between those who were in exile and those who were inside the country. Their hearts are still full of anger and bitterness. Therefore, I propose a truthful commission to be established in Namibia, to reconcile the Namibian people.

Mr. Speaker Honourable members another omission is the persistence problem

of elephant destroying crops; omahangu, omatanga. Which is never addressed in the budget, to compensate the losses and the Minister did not bother to allocate money to address this cruel killing of human in the river at Kavango and Kunene. I propose the Ministry to erect iron bars along the river, where the community fetch water to prevent crocodiles not to catch the people. Just brilliant and cheap, rather than to allow human life to get lost. I again propose for those who were killed at the river or by elephants, their funerals to be covered by the state and to be compensated.

Another omission, they did not increase the allowance of senior traditional leaders. And failed dismal to initiate allowance for headmen and sub-headmen.
