## 3.0 OPENING STATEMENT BY THE CHAIRPERSON

Hon. Mensah-Williams, Chairperson of the National Council made a Statement to the House at the opening of the Tenth Session of the 5<sup>th</sup> National Council on 21 November 2017. The Statement is reproduced hereunder:

Welcome back honourable members from all the corners of our beautiful country.

We thank the Almighty God for keeping us safe once again during our journeys to Windhoek and ask for him to grant us wisdom over the next weeks or so.

With the powers vested in us in terms of Chapter 8 of the Constitution of the Republic of Namibia; we have gathered once again to fulfill our constitutional mandate as the legislative branch of the State.

Ladies and gentlemen,

From today until November the 30th, we will review the bills that have been passed and referred to us by the National Assembly. Among others, this august house will consider the Property Valuers Profession Amendment Bill, Bill No.18 of 2016; and the Combating of Trafficking in Persons Bill, Bill No.14 of 2017.

In addition, this august house will also consider a number of reports by standing committees that were hard at work during the intervening time.

I would like to make particular mention of the report on 'Human-Wildlife Conflict' which is going to be tabled by the Standing Committee on Habitat following nationwide consultations.

Recent news reports of a pride of lions which killed more than 200 small livestock in the Kunene Region show what a serious and urgent matter this is.

You will all agree with me that conflict between people and wild animals is one of the main threats to the continued survival of our precious wild animals. I believe, therefore, that if solutions to conflicts are not adequate, local support for the Government's conservation efforts will decline.

The last thing we want is a situation in which people start to take the law into their own hands. Hence, honourable members, we must strike a balance between the needs of the farmers and those of the conservationists.

Ladies and gentlemen,

You may recall that during our last seating, the National Assembly had referred a number of the Auditor General's audit reports on regional and local authorities to this house for scrutiny.

The National Council is obligated by law to scrutinize these reports within the year it received them.

Since our last seating in May, the Standing Committee on Public Accounts and Economy has extensively dissected the reports and called regional councils and local authorities to account for their actions.

The goal of scrutinizing of the Auditor General's audit reports is to generate recommendations for improving public service delivery and to ensure accountability and transparency in the utilization of public funds.

The scrutiny of the reports will further indicate to the public how regional and local authorities performed during the fiscal periods under review.

Honourable Members,

I would like to take this opportunity to thank all the chairpersons of standing committees and the entire staff compliment for ensuring that all the reports that were due are indeed ready for tabling as planned.

Honourable Members.

I would like to call upon you to ensure that the National Council aligns itself with the objectives of both the Harambee Prosperity Plan, the National Development Plan 5, as well Vision 2030.

With these few words, I would like to invite members of the public to follow the proceedings in the house; preferably in person in the Chamber or watch the seating live on NBC-TV.

On behalf of the National Council, I rise to congratulate Hon. Margaret Mensah-Williams, the Chairperson of the National Council on her two recent international achievements.

- 2. Raise awareness about infertility prevention and management, including male infertility, by integrating it into already existing national healthcare infrastructure;
- 3. Educate and train African embryologists in order to address the lack of trained and skilled staff;
- 4. Support policymakers to define policies to improve access to regulated fertility care.
