The MGECW and the whole GRN machinery, all stakeholder and the General Public at large, we all have the obligations as by the Namibia Constitution to uphold and defend the constitution and the Laws of the Republic. Article six(6) of the Constitution states about protection of life. It clearly gives instructions to every human being in our society to respect and protect the right to life. Article 8(2)b is saying, no person shall be subjected to torture or to cruel inhuman or degrading treatment or punishment.

In addition to Namibia is a signatory to the international and regional instruments, which have a bearing on GBV, and has brought into force a number of National Laws and Policies to combat GBV, among others are

- Combating of Rape Act 8 of 2000
- Combating of Domestic Violence Act 4 of 2004
- Criminal Procedure Amendment Act 24 of 2003
- Maintenance Act 9 of 2003

Despite of the directives of the Constitution and Laws, we still observe or witness the violations of these provisions by some elements within our society, who have got the liberty of taking the law into their own hands. I am warning that, there is no one above the Law, no one. This criminality of turn to murder innocent women and children should stop.

The MGECW's intent this time around, is to double our effort to comply with the provisions of our Constitution and the Laws of the Republic, that the Namibian House should not be destroyed by satanic behaviours.

Therefore the MGECW has planned to launch the mass media campaign against GBV. This campaign will be launch on Friday the 10th of July 2015 at Safari Hotel. It will be launched by Her Excellency the 1st Lady of the Republic of Namibia, Madame Monica Geingos.

The campaign will be through radio drama series and gradually through TV series. We have decided as Ministry and our stakeholders not to leave any stone unturned, until the war against GBV is definitely defeated.
