MINUTES OF PROCEEDINGS OF THE NATIONAL ASSEMBLY

TUESDAY, 23 APRIL 2013

The Assembly met pursuant to the adjournment.

- 1. The Speaker took the Chair and read the Prayer and Affirmation.
- 2. Announcements by the Speaker in terms of Rule 20(b) of the Standing Rules and Orders:
 - (a) The Speaker welcomed the two visiting parliamentary delegations from the Parliament of Zambia in the Galleries.

One is a twelve Member delegation led by Hon. Edgar Singombe, Chairperson of the Parliamentary Committee on Local Governance, Housing and Chiefs' Affairs.

The second is an eight Member delegation led by Hon. Kabinga J. Pande, Chairperson of the Parliamentary Committee on Information and Communication Technology.
