As concerned citizens of the Republic of Namibia, we strongly wish to draw your attention to the recent protest that took place on the 19th April 2019 in the streets of Windhoek, demanding the amendment of Act 41 0f 1971 in favour of legalization of marijuana.

- Sleeping most of the time (even a whole day or days after days)
- Domestic violence
- Vandalizing of property

In Namibia we have the Turning Point Rehabilitation Center whereby many of the inmates are x-marijuana users. These youths are valuable resources should the nation wish to hear it from the camel's mouth. Another useful source of information on this background is our neighboring country South Africa that has just legalized marijuana. 
