# REPUBLIC OF NAMIBIA MINUTES OF PROCEEDINGS OF THE NATIONAL ASSEMBLY

# WEDNESDAY, 15 SEPTEMBER 2021

The Assembly met pursuant to the adjournment.

1. The Speaker took the Chair and read the Prayer and Affirmation.

#### 4. Ministerial Statement in terms of Rule 98 of the Standing Rules and Orders:

The Deputy Prime Minister and Minister of International Relations and Cooperation informed the Assembly that at the directive of the President of Namibia and Botswana, and in the company of high ranking officials of both countries, they visited the Chobe District in Botswana and Zambezi Region from 2 - 3 September 2021. The Deputy Prime Minister reported that during the joint visit they urged the Chobe District and Zambezi Region Council to enter into a twinning agreement, and on that basis re-affirmed the continuous enjoyment by nationals of both countries of equal access and treatment to the shared natural resources along the common riverine boundaries

#### 5. Announcement by the Speaker:

The Speaker informed the Assembly on the virtual meeting he had with the rest of the world, as part of the family of the Inter-Parliament Union (IPU), on the occasion of the Conference on the International Day of Democracy, under the theme '*Role of Legislature in Fostering Effective and Meaningful Democracy*', The event is celebrated annually on the 15 September.

That leave be given to introduce a Bill to provide for the appointment of an independent and impartial Information Commissioner and Deputy Information Commissioners; to provide for the obligations of public entities; to provide for the right of access to information held by public and private entities; to provide for the promotion, creation, keeping, organisation and management of information in the form and manner that facilitates transparency, accountability, good governance and access to information; to provide for requests for access information; to provide for internal review, appeal and judicial review of decisions on access to information; to provide for information exempt from disclosure; and to provide for incidental matters.

Agreed to.

Access to Information Bill [B. 4 – 2020] read a First Time.

The Minister of Information and Communication Technology moved, subject to Rule 32(a) of the Standing Rules and Orders, seconded by Dr. Aupindi: That the Bill be read a Second Time.

On the motion of Mr. Shixwameni, seconded by Ms. Tjiveze, debate adjourned until Tuesday, 21 September 2021.
