THURSDAY, 11 NOVEMBER 2021

Income Tax Laws Amendment Bill [B. 11 – 2021] read a First Time.

The Minister of Finance moved, subject to Rule 32 (a) of the Standing Rules and Orders, seconded by the Prime Minister: That the Bill be read a Second Time.
