**TUESDAY, 16 NOVEMBER 2021**

The Assembly met pursuant to the adjournment.

1. The Speaker took the Chair and read the Prayer and Affirmation.
2. **Announcement by the Speaker in terms of Rule 20(b) of the Standing Rules and Orders:**

The Speaker reported that after last week Thursday's consultation between the Deputy Speaker and the Chief Whips of the various political parties to extend the sitting of this Session, that he authorise that the extension be extended from the 25 November 2021 to 2 December 2021, in terms of Rule 15(i) of the Standing Rules and Orders to enable the Assembly to finish the items on the Order Paper.
