**TUESDAY, 23 NOVEMBER 2021**

The Assembly met pursuant to the adjournment.

1. The Deputy Speaker took the Chair and read the Prayer and Affirmation.

The Speaker Reported that all Hon. Members are hereby informed that the memorial service of our late Comrade Hon. Ignatius Nkotong Shixwameni is going to take place this afternoon, 23 November 2021 at the Roman Catholic St. Mary's Cathedral in Windhoek at 17:00.
