REPUBLIC OF NAMIBIA MINUTES OF PROCEEDINGS OF THE NATIONAL ASSEMBLY

THURSDAY, 23 SEPTEMBER 2021

The Assembly met pursuant to the adjournment.

- 1. The Deputy Speaker took the Chair and read the Prayer and Affirmation.
- 2. Announcement by the Deputy Speaker in terms of Rule 20(b) of the Standing Rules and Orders:

4. Mr. Venaai moved without Notice in terms of Rule 27(i) of the Standing Rules and Orders:

The Minister of Agriculture, Water and Land Reform updated the Assembly and the public at large on the status of the Foot and Mouth Disease (FMD) outbreak at Kasenu Village of Kabbe South Constituency in the Zambezi Region and the FMD serotypes that caused it, as was detected on 28th May 2021 by the Ministry of Agriculture, Water and Land Reform and subsequently confirmed by the Central Veterinary Laboratory (CVL) on the 3rd of June 2021.
