TUESDAY, 28 SEPTEMBER 2021

The Assembly met pursuant to the adjournment.

1. The Speaker took the Chair and read the Prayer and Affirmation.

2. **Mr. Ithete laid upon the Table for discussion:**

Report by the Parliamentary Standing Committee on Economics and Public Administration on the Stakeholder Consultation Workshop held at Otjiwarongo from 10 – 14 May 2021.

3. **The Deputy Minister of Finance laid upon the Table:**
