# REPUBLIC OF NAMIBIA MINUTES OF PROCEEDINGS OF THE NATIONAL ASSEMBLY

## **WEDNESDAY, 16 FEBRUARY 2022**

The Assembly met pursuant to the adjournment.

If successfully and timely implemented, free wi-fi will enable learners and graduates countrywide to access educational information indiscriminately, freely access information relating to employment and other opportunities, have access to other crucial information including following parliamentary debates, prepare the country to transform into the 4<sup>th</sup> industrial revolution as well as conforming to the Agenda 63 of the African Union with regard to digital transformation.
