REPUBLIC OF NAMIBIA MINUTES OF PROCEEDINGS OF THE NATIONAL ASSEMBLY

THURSDAY, 3 MARCH 2022

The Assembly met pursuant to the adjournment.

- 1. The Speaker took the Chair and read the Prayer and Affirmation.
- 2. Announcements by the Speaker in terms of Rule 20(b) of the Standing Rules and Orders:
 - (i) The Speaker reported that after consultations with the Chief Whips of political parties, an agreement was reached to sit on Monday, 7 March 2022 to allow Hon. Nico Smit of the Official Opposition party PDM to respond to the Budget as tabled by the Minister of Finance.

Question put and agreed to sit on Monday.
