# REPUBLIC OF NAMIBIA MINUTES OF PROCEEDINGS OF THE NATIONAL ASSEMBLY

## **TUESDAY, 8 MARCH 2022**

The Assembly met pursuant to the adjournment.

- 1. The Speaker took the Chair and read the Prayer and Affirmation.
- 2. Announcements by the Speaker in terms of Rule 20(b) of the Standing Rules and Orders:
  - (i) The Speaker expressed deepest sympathy and condolences on the passing on of Hon. Immanuel Ngatjizeko. Honourable Ngatjizeko who passed away on Saturday, 5 March 2022, served as a Member of the National Assembly from 2000 and held various ministerial position until his retirement in 2018. During his tenure as Member of this august House, he served the Namibian people with humility and dedication.

## 8. THIRD NOTICE OF A MOTION:

Mr. Venaani moved, seconded by Mr. Tjeundo:

That this Assembly –

Discuss alternative housing financing schemes, necessitated by the exuberant sums of money that banks charge home-owners, the bank mortgage credit processes that discriminate against self-employed and lower-income earning individuals and the slow production of housing that has inflated housing prices, making them unaffordable to the lower mass market segment.

The key affordable housing issues in Namibia are high urbanization rates, the lack of access to affordable housing and finance, the lack of serviced land, the poor production of housing stock, and the increasing number of informal settlements across the country.

Currently, there are 285 informal settlements in towns across Namibia, meaning 40% of its urban inhabitants or 216 000 urban households are informally settled, which is indicative of the high urbanization rates across the country.

That this Motion be referred to a Parliamentary Standing Committee for further scrutiny and report back to this Assembly.

On the motion of Ms. Dienda, seconded by Mr. Smit, debate adjourned until Wednesday, 9 March 2022.
