**FRIDAY, 22 APRIL 2022**

The Assembly met pursuant to the adjournment.

1. The Speaker took the Chair and read the Prayer and Affirmation.
2. **Mr. Hambyuka moved without notice:**

That the proceedings on Votes 3, 9, 11, 27, 34, 36, 37 and 38 of the *Appropriation Bill* be, in terms of Rule 103(a) of the Standing Rules and Orders, not interrupted if still under consideration at 12:30.

Agreed to.

3. **FIRST ORDER READ:**

Resumption of Committee Stage – *Appropriation Bill* [B. 3 – 2022].

The Minister of Finance moved, seconded by Mr. Dingara: That the Assembly now goes into Committee.

Agreed to.

**ASSEMBLY IN COMMITTEE:**

The Chairperson of the Whole House Committee stated that when progress was reported yesterday, 21 April 2022, Votes 34, 36, 37 and 38 had been introduced, while Votes 1, 2, 4, 7, 8, 10, 13, 14, 15, 16, 17, 18, 19, 21, 22, 23, 24, 26, 28, 29, 30, 31, 32 and 39 had been discussed and agreed to. Votes 3, 9, 11 and 27 had been discussed and replied to but stood over for adoption due to a lack of a voting quorum.

For adoption:

Vote 27 – Sport, Youth and National Service: Put and agreed to.

Vote 3 – National Assembly: Put and agreed to.

Vote 9 – Finance: Put and agreed to.  
Vote 11 – National Council: Put and agreed to.

For discussion:

Vote 34 – Public Enterprises: Agreed to unanimously.  
Vote 36 – Gender Equality, Poverty Eradication and Social Welfare: Discussed and agreed to.  
Vote 37 – Agriculture and Land Reform: Discussed and agreed to.  
Vote 38 – Water: Agreed to unanimously.

IN THE BILL:

Clause 1 put and agreed to.  
Clause 2 put and agreed to.  
Schedule put and agreed to.  
Title put and agreed to.

ASSEMBLY RESUMED:

Bill reported without amendments.

The Minister of Finance moved, seconded by the Minister in the Presidency: That the Bill be read a Third Time.

Agreed to.

*Appropriation Bill* [B. 3 – 2022] read a Third Time.

4. In terms of Rule 99(a) of the Standing Rules and Orders, the Speaker adjourned the Assembly at 14:32 until Tuesday, 26 April 2022.
