# REPUBLIC OF NAMIBIA MINUTES OF PROCEEDINGS OF THE NATIONAL ASSEMBLY

# **WEDNESDAY, 8 JUNE 2022**

The Assembly met pursuant to the adjournment.

1. The Speaker took the Chair and read the Prayer and Affirmation.

## 2. The Deputy Minister of Finance laid upon the Table:

Reports of the Auditor-General on the Accounts of the -

- (i) Ministry of Information and Communication Technology for the financial year ended 31 March 2021;
- (ii) Department of Transport of the Ministry of Works and Transport for the financial year ended 31 March 2021;
- (iii) Ministry of Education, Arts and Culture for the financial year ended 31 March 2021;
- (iv) Ministry of Fisheries and Marine Resources for the financial year ended 31 March 2021; and
- (v) Office of the Auditor-General for the financial year ended 31 March 2021.

That leave of absence, due to official duties, be granted to Hon. Emma Theofelus, until 5 July 2022.
