REPUBLIC OF NAMIBIA MINUTES OF PROCEEDINGS OF THE NATIONAL ASSEMBLY

TUESDAY, 28 JUNE 2022

The Assembly met pursuant to the adjournment.

1. The Speaker took the Chair and read the Prayer and Affirmation.

2. The Deputy Minister of Finance laid upon the Table:

Reports of the Auditor-General on the Accounts of the -

- (i) Ministry of Industrialisation and Trade for the financial year ended 31 March 2021;
- (ii) National Council for the financial year ended 31 March 2021;
- (iii) Ministry of Sport, Youth and National Service for the financial year ended 31 March 2021;
- (iv) Department of Works of the Ministry of Works and Transport for the financial year ended 31 March 2021;
- (v) Office of the President for the financial year ended 31 March 2021;
- (vi) Ministry of Health and Social Services for the financial year ended 31 March 2021;
- (vii) Department of Agriculture and Land Reform for the financial year ended 31 March 2021; and
- (viii) Department of Home Affairs and Immigration of the Ministry of Home Affairs, Immigration, Safety and Security for the financial year ended 31 March 2021.

6. Ministerial Statement in terms of Rule 98 of the Standing Rules and Orders:

The Minister of Agriculture, Water and Land Reform addressed the Assembly to clear misinformation which has been circulating in the public domain during the past two weeks, that foreign nationals can now own communal land. The Minister said Section 32 of the Land Bill restricts the acquisition of customary land rights by foreign nationals who cannot enter in any agreement with any person who hold a customary land right without a written prior approval from the Minister.

The Minister appealed to the Namibian populace to verify facts themselves instead of relying on their political or spiritual Messiahs to interpret things for them.

The Minister of Agriculture, Water and Land Reform moved, seconded by the Minister of Urban and Rural Development:
