# MINUTES OF PROCEEDINGS

# 4.0 OPENING STATEMENT BY CHAIRPERSON

Honourable Muha, Chairperson of the National Council made a Statement to the House at the opening of the Fifth Session of the 6<sup>th</sup> National Council on Monday, 01 August 2022.

The Statement is reproduced hereunder:

"Honourable Gerhard Shiimi, Chief Whip, and all Whips; Honourable Members; Adv. Tousy Namiseb, Secretary to the National Council; National Council Staff Members; Media Representatives; Ladies and Gentlemen;

We are once again gathered here in this August House for the next three weeks to deliberate on matters of Regional and National concern as per Article 74 and 75 of the Namibian Constitution.

Honourable Members, I comment you that for the past twenty months, you have demonstrated your responsibilities of representing, reviewing and holding the executive accountable.

As Members of Parliament at National Council, it is important to note that our recess are normally working sessions. During the just ended recess, the Council has recorded a number of activities; that included:

- 1. The familiarization visits to Recon Africa / Namibia exploration site that took place on 27<sup>th</sup> of June 2022,
- As a branch of Commonwealth Parliamentary Association (CPA), we participated in the 52<sup>nd</sup> CPA Africa Regional Conference held in Freetown, Sierra Leone from 03-09 June 2022,
- 3. Furthermore, we attended and participated in the plenary of Pan African Parliament (PAP) in June 2022. It is indeed my distinct honour to comment the SADC delegation (to that conference) for ensuring the delivery of PAP chairmanship to the Southern African candidate, Hon. Fortune Z. Charumbira from Zimbabwe. Hon. Members, Please, join me as I congratulate Hon. Charumbira for his new assignment.

- National Council further conducted capacity building training on Women in Politics and decision making from 13-14 June 2022.
- 5. I am equally happy to inform this August house that the training workshop on leadership and management meant for Chairpersons and Deputy-Chairpersons of National Council Standing Committees, from 11-15 June 2022, has been successful, and
- 6. The just concluded National Council Chairperson's Outreach Programme, under the able leadership of Hon. Vicky Kauma, Vice-Chairperson of the National Council to Oshana, Omusati and Kunene regions, from 18-30 July 2022, is one of the very important activities undertaken by National Council during the recess. The outreach program is aimed at creating awareness among stakeholders on the work of Parliament. Since its inception, the public (target group) has shown much appreciation.

Honourable Members, I further would like comment many of you for not observing the recess but rather opted to be busy engaging communities in our various constituencies. Similarly, do I encourage those who did not yet start visiting communities to follow suit as this will enable us to inform them on government programs and activities. The fact that many of us regularly visit communities is a clear demonstration that we are committed to our elementary responsibilities.
