# REPUBLIC OF NAMIBIA MINUTES OF PROCEEDINGS OF THE NATIONAL ASSEMBLY

## TUESDAY, 18 OCTOBER 2022

The Assembly met pursuant to the adjournment.

1. The Speaker took the Chair and read the Prayer and Affirmation.

#### 2. The Minister of Information and Communication Technology laid upon the Table:

Integrated Annual Report of the Communications Regulatory Authority of Namibia (CRAN) for the year 2021.

#### 3. NOTICES OF QUESTIONS:

- (i) Mr. Seibeb (LPM) to ask the Minister of Justice (No. 135).

#### 4. The Deputy Minister of Works and Transport moved without notice:

That his Motion to discuss the overcharges, unethical and unwarranted multiple charges by Namibia Commercial Banks, as well as to discuss the perpetual colonial legacy of class and race discrimination of clients by Namibian Commercial Banks, be withdrawn in terms of Rule 30 Sub-rule (b), but that he will again move it after notice in terms of Rule 30(c), when the Assembly is going to resume next year.

The Minister of Finance moved, seconded by Mr. Katamelo: That the Bill be read a Third Time.

Agreed to.

Abolition of Payment by Cheque Bill [B. 5 – 2022] read a Third Time.
