# REPUBLIC OF NAMIBIA MINUTES OF PROCEEDINGS OF THE NATIONAL ASSEMBLY

#### WEDNESDAY, 19 OCTOBER 2022

The Assembly met pursuant to the adjournment.

1. The Speaker took the Chair and read the Prayer and Affirmation.

# 2. Announcements by the Speaker in terms of Rule 20(b) of the Standing Rules and Orders:

(i) The Speaker announced that at today's graduation ceremony, the University of Namibia honoured one of the Founding and long serving Member of the National Assembly until his retirement in 2015, Gaob Justus |Uruhe ||Garoëb with the Honorary Degree, Doctor of Philosophy in Political Science (Studies) *Honoris Causa*.
