REPUBLIC OF NAMIBIA MINUTES OF PROCEEDINGS OF THE NATIONAL ASSEMBLY

TUESDAY, 4 OCTOBER 2022

The Assembly met pursuant to the adjournment.

1. The Speaker took the Chair and read the Prayer and Affirmation.

2. Announcements by the Speaker in terms of Rule 20(b) of the Standing Rules and Orders:

(i) Now that we are operating under the relax COVID – 19 regulations, the Speaker announced that the galleries in the Chamber are now accessible for the members of the public.

The Speaker said members of the public are now welcome to come and observe the proceedings of the Assembly, and the same applies to the tours of the National Assembly by school children, interested groups and people.

(ii) The Speaker reminded all Members of the National Assembly and in particular Members from the Executive Branch of Government that in terms of Rule 34(e) "No Bills shall be tabled before the Assembly after 1 November each year, unless the Speaker considers the matter urgent in accordance with Rule 52".

Rule 52 provides partly that; "A Minister may declare in the House that the Bill is an urgent Bill, and on such a declaration, the question "That the Bill is an urgent Bill", shall be put forthwith: Provided that the Presiding Member is satisfied that such a motion is not a misuse of the Standing Orders, or infringes on the rights of the minority".

The Speaker advised the Members that there are now approximately 4 weeks before the deadline and urged the Members to submit *Bills* before the deadline taking into consideration that the National Council also must review the *Bills* passed by the National Assembly.

Clause 1 as amended by the National Council, put and agreed to. Clause 6 as amended by the National Council, put and agreed to. Clause 25 as amended by the National Council, put and agreed to. Clause 50 as amended by the National Council, put and rejected. Clause 72 as amended by the National Council, put and agreed to.
