REPUBLIC OF NAMIBIA MINUTES OF PROCEEDINGS OF THE NATIONAL ASSEMBLY

WEDNESDAY, 15 MARCH 2023

The Assembly met pursuant to the adjournment.

1. The Deputy Speaker took the Chair and read the Prayer and Affirmation.

2. Ruling by the Deputy Speaker with regard to the use of the Public Gallery:
