## REPUBLIC OF NAMIBIA MINUTES OF PROCEEDINGS OF THE NATIONAL ASSEMBLY

### WEDNESDAY, 29 MARCH 2023

The Assembly met pursuant to the adjournment.

1. The Speaker took the Chair and read the Prayer and Affirmation.

# 2. Announcement by the Speaker in terms of Rule 20(b) of the Standing Rules and Orders:

The Speaker together with the House congratulated the national football team, namely Brave Warriors, on their splendid performance yesterday, 28 March 2023. As is known, Namibia now qualifies for the AFCON Championships, which is a major achievement for the team and the nation at large. The country wishes the team the very best and simply say, "Bring the Cup Home Boys".

# 3. Hon. Hambyuka moved without Notice in terms of Rule 27(d) of the Standing Rules and Orders:

Vote 15 – Mines and Energy: Discussed and agreed to.

Vote 29 – Information and Communication Technology: Discussed and agreed to.

Vote 32 - Higher Education, Technology and Innovation: Discussed and agreed to.

Vote 39 - Home Affairs, Immigration, Safety and Security: Discussed and agreed to.

#### ASSEMBLY RESUMED:

Progress reported and leave granted to sit again.
