SEVENTH SESSION, SEVENTH PARLIAMENT

REPUBLIC OF NAMIBIA MINUTES OF PROCEEDINGS OF THE NATIONAL ASSEMBLY

WEDNESDAY, 5 APRIL 2023

The Assembly met pursuant to the adjournment.

- 1. The Speaker took the Chair and read the Prayer and Affirmation.
- 2. Announcements by the Speaker in terms of Rule 20(b) of the Standing Rules and Orders:
 - (i) The Speaker reported that he has been informed by the Chief Whip of the SWAPO Party that the Party has withdrawn Hon. Natangue Ithete from the Standing Committee on Foreign Affairs, Defence and Security, and nominated him to serve on the Standing Committee of Human Resources and Community Development.
 - (ii) The Speaker reported that he has also received a communication from the All People's Party (APP) that they have withdrawn Hon. Erastus Shuumbwa from the Committee on Standing Rules and Orders and Internal Arrangements, and nominated Hon. Maria Kamutali to serve on the said Committee.
 - (iii) The Speaker further reported that he has also received a communication from the Rally for Democracy and Progress (RDP) that they have nominated Hon. Kennedy Hiskia Shekupakela as the leader of the Party in the National Assembly, and also nominated him to serve on the following Standing Committees and Multilateral Parliamentary Organizations:
 - Committee on Standing Rules and Orders and Internal Arrangements;
 - Committee on Public Accounts; and
 - Committee on Economics and Public Administration, and Inter Parliamentary Union (IPU).

The Speaker declared these Members as duly nominated to the said Committees.

- (iv) Lastly, the Speaker also reported that he has been informed by the Christiaan Democratic Voice (CDV) Party that Hon. Gotthard Kandume has withdrew from the following Standing Committees:
 - Committee on Foreign Affairs, Defence and Security;
 - Committee on Natural Resources;
 - Committee on Economics and Public Administration; and
 - Committee on Public Accounts.

Discusses that this House carries out a comprehensive inquiry into all aspects of the procedures dictating the tender awarding processes of the Central Procurement Board of Namibia.

There is growing public concern regarding the operations and decisions of the Central Procurement Board of Namibia, which was established by the Public Procurement Act 15 of 2015. Distrust, perceptions of procedural unfairness, corruption, insider trading and manipulation, are regular themes of public discourse as it relates to the tender awarding process. It is against this background that an inquiry is of urgency.

Further, that this Motion be referred to the relevant Parliamentary Standing Committee for further scrutiny and report back.
