EIGHTH SESSION, SEVENTH PARLIAMENT

REPUBLIC OF NAMIBIA MINUTES OF PROCEEDINGS OF THE NATIONAL ASSEMBLY

TUESDAY, 19 SEPTEMBER 2023

The Assembly met pursuant to the adjournment.

- 1. The Speaker took the Chair and read the Prayer and Affirmation.
- 2. Announcements by the Speaker in terms of Rule 20(b) of the Standing Rules and Orders:
 - (i) The Speaker announced that the *Godwana Collection Namibia* is inviting all Members to the launch of the *Tourism Heroes Campaign Award* and the presentation ceremony of the first award to the Tourism Against Crime Organization. The event will take place today, during our health break in the Parliament courtyard.

5. FIRST NOTICE OF A MOTION:

Hon. Hamata moved, seconded by Hon. Araes:

Long distance marriages can be pretty daunting. They can take a toll on the mental and physical health of spouses and their children.

All children have the right to grow up with both their parents, in the same environment. Children in family environments are generally safer and better cared for, yet things like long-distance marriages force hundreds of children from their biological parents each year and vice versa. These spouses and children suffer extreme stress when split from each other for months, sometimes years on end. Separation undermines children's development. What's more, it leaves them vulnerable to violence, exploitation and abuse.

Article 14(3) of our Constitution makes provision for the family being the natural and fundamental group unit of society, and is entitled to protection by society and the State.

That this Assembly therefore -

Discusses the issue of family separation due to long-distance marriages and the negative impacts this has on the psychological health and financial status of families as they now have to struggle to keep up with maintain two households in different towns, or regions.

Further, that this Motion be referred to a relevant Parliamentary Stranding Committee for further investigation and informed counsel.

On the motion of Hon. Van Wyk, seconded by Hon. Van den Heever, debate adjourned until Tuesday, 3 October 2023.

6. **SECOND NOTICE OF A MOTION:**

Hon. Mootu moved, seconded by Hon. Isaaks:

That this Assembly -

Discusses the suitable housing options in Namibia to address housing shortage and funding gaps.

Further, that this Motion be referred to a relevant Parliamentary Standing Committee for further scrutiny and report back.
