# REPUBLIC OF NAMIBIA MINUTES OF PROCEEDINGS OF THE

## NATIONAL ASSEMBLY

## WEDNESDAY, 20 SEPTEMBER 2023

The Assembly met pursuant to the adjournment.

- 1. The Speaker took the Chair and read the Prayer and Affirmation.
- 2. Announcements by the Speaker in terms of Rule 20(b) of the Standing Rules and Orders:
  - (i) The Speaker announced that he has been informed by the Chief Whip of the SWAPO Party that the Party has nominated Hon. Maria Elago and Hon. Dr. Becky Rebecca Ndjoze-Ojo to serve on the Committee on Standing Rules and Orders and Internal Arrangements.
  - (ii) That he has also been informed by the Chief Whip of PDM that the Party has reassigned and nominated the following Members to the various Parliamentary Standing Committees as follows:
    - Hon. Jennifer van den Heever and Hon. Yvette Araes to serve on the Standing Committee on Economics and Public Administration;
    - Hon. Maximalliant Katjimune and Hon. Jan Van Wyk to serve on the Standing Committee on Foreign Affairs, Defence and Security;
    - Hon. Inna Hengari, Hon. Hidipo Hamata and Hon. Frans Bertolini to serve on the Standing Committee on Human Resources and Community Development,
    - Hon. Charmaine Tjirare to serve on the Standing Committee on Information Communication, Technology and Innovation, and
    - Hon. Frans Bertolini to serve on the Standing Committee on Natural Resources.
  - (iii) That he has further been informed by the Chief Whip of LPM that they have nominated Hon. Henny Hendley Seibeb to serve on the Standing Committee on

Human Resources and Community Development; and Standing Committee on Equality, Social Development and Family Affairs.

The Speaker declared these Members as duly elected to the said Parliamentary Standing Committees.

#### 7. FIRST NOTICE OF A MOTION:

Hon. Seibeb moved, seconded by Hon. Mootu:

That this Assembly -

Discusses the plight of the small-scale miners in the Erongo Region.

Further, that this Motion be referred to a relevant Parliamentary Standing Committee for further scrutiny and report back.

It was conceded that since the Standing Committee on Natural Resources already had meetings with small-scale miners among others in the Erongo Region on the same issues and concerns raised by Hon. Seibeb during his motivation, that this Motion be set aside to allow consultation to take place first between Hon. Seibeb and the Chairperson of the Natural Resources Committee Hon. Tweya.

#### 8. **SECOND NOTICE OF A MOTION:**

Hon. Moongo moved, seconded by Hon. Katjimune:

Pregnancy and maternity are potentially vulnerable time for working women and their families. Expectant mothers and fathers, and nursing mothers require special protection to prevent any potential adverse effects for them and their infants.

That this House therefore -

*Discusses* the possibility of increasing the amount payable in respect of maternity leave, extending maternity leave duration up to five months with full pay, and including paternity leave in the legislative framework.

That this Motion be referred to a relevant Parliamentary Standing Committee for further inquiry and report back to this Assembly.

On the motion of Hon. Araes, seconded by Hon. Hengari, debate adjourned until Tuesday, 3 October 2023.
