## REPUBLIC OF NAMIBIA MINUTES OF PROCEEDINGS OF THE NATIONAL ASSEMBLY

## THURSDAY, 21 SEPTEMBER 2023

The Assembly met pursuant to the adjournment.

1. The Speaker took the Chair and read the Prayer and Affirmation.

# 2. The Speaker presented and laid upon the Table, in terms of Rule 96(a) of the Standing Rules and Orders –

A Petition by the Namibian National Association of the Deaf, received today, 21 September 2023.

In the Petition, the Association is calling for the Recognition of Namibian Sign Language as a National language. They say that their language is not recognized and this has affected their lives and deprived their full participations in the society.

The Speaker said this Petition is going to be submitted to the Standing Committee dealing with Petitions, to draw up rules governing the treatment of requests and complaints and shall use them as the basis for its decisions in each case.

Mr. Stanley's stoic record as the facilitator for the Founding Father to go into exile is pivotal in the liberation narrative of Namibia. His audacious- act of aiding Founding President Dr, Sam Nujoma in escaping into exile in 1960 was a catalyst that set the wheels of revolution in motion, ultimately leading to the birth of a sovereign Namibia.

That this Motion be referred to a relevant Parliamentary Standing Committee to propose recommendations to this august House after conducting diligent work on the subject matter.

On the motion of the Deputy Minister of Finance and Public Enterprises, seconded by Hon. Kandjimi, debate adjourned until Wednesday, 27 September 2023.

That this Assembly -

*Discusses and agrees* to the inclusion of Namibian former mine workers in South Africa on the ongoing compensation targeting all former mine workers in Southern African mines.

Hon. Hambyuka drew the attention of the Deputy Speaker that there is no Quorum in the Houses.
