NOTICE OF A MOTION

Hon. Diergaardt:

That this Assembly –

Discusses the accessibility and affordability of Rehabilitation Centres in Namibia and consider the establishment of more State-owned Rehabilitation Centres that offer affordable services to all Namibians.

That this Motion be referred to the relevant Parliamentary Standing Committee to propose recommendations to this August House after conducting diligent work on the subject matter.

Finally, that the relevant Parliamentary Standing Committee, in conformity with the rule be encouraged to have associate Members of Parliament to its work.
