REPUBLIC OF NAMIBIA MINUTES OF PROCEEDINGS OF THE

NATIONAL ASSEMBLY

MONDAY, 20 NOVEMBER 2023

The Assembly met pursuant to the adjournment.

1. The Speaker took the Chair and read the Prayer and Affirmation.

2. **NOTICES OF QUESTIONS:**

- (i) Hon. Seibeb (LPM) to ask the Minister of Mines and Energy (No. 234).
- (ii) Hon. Seibeb (LPM) to ask the Minister of Education, Arts and Culture (No. 235).
- (iii) Hon. Seibeb (LPM) to ask the Minister of Mines and Energy (No. 236).

3. Hon. Shekupakela moved without Notice:

That leave of absence due to illness, be granted to Hon. Murorua until further notice.

Agreed to.

4. **FIRST, SECOND and THIRD ORDERS** skipped for a time being due to a lack of 49 Hon. Members entitled to vote.

5. **FOURTH ORDER READ:**

Agreed to.

6. **FIRST ORDER READ:**

Resumption of Debate on Second Reading – *Appropriation Amendment Bill* [B. 21 – 2023].

Question before the Assembly on Thursday, 16 November 2023, as moved by the Minister of Finance and Public Enterprises (page 232).

Question put: That the Bill be read a Second Time.

Agreed to.
