NATIONAL ASSEMBLY

TUESDAY, 7 NOVEMBER 2023

The Assembly met pursuant to the adjournment.

- 1. The Speaker took the Chair and read the Prayer and Affirmation.

5. **NOTICE OF A MOTION:**

The Minister of Works and Transport moved, seconded by the Minister of Home Affairs, Immigration, Safety and Security:

That leave be given to introduce a Bill to provide for the minimisation of excessive damage to the national road network; to provide for the accreditation and auditing of weigh stations; to provide for the permissible mass for vehicles using the national road network; to provide for the adjudication process for certain violations; and to provide for incidental matters.

Agreed to.

Mass Vehicle Bill [B. 19 – 2023] read a First Time.

The Minister of Works and Transport moved, subject to Rule 32(a) of the Standing Rules and Orders, seconded by the Minister of Mines and Energy: That the Bill be read Second Time.
