REPUBLIC OF NAMIBIA MINUTES OF PROCEEDINGS OF THE NATIONAL ASSEMBLY

TUESDAY, 27 FEBRUARY 2024

The Assembly met pursuant to the adjournment.

1. The Speaker took the Chair and read the Prayer and Affirmation.

2. Announcement by the Speaker in terms of Rule 20(b) of the Standing Rules and Orders:

The Speaker announced that with the tabling of the 2024/2025 *Appropriation Bill* by the Minister of Finance and Public Enterprises tomorrow, Wednesday 28 February 2024, the National Assembly with the support of Standard Bank Namibia will be serving welcoming soft drinks to the Members in the courtyard. Hon. Hamata moved, seconded by Hon. Muharukua:

That this Assembly -

Discusses the disparity between private and public schools continues to widen, with the latter's performance deteriorating year in, year out. This unsettling trend has been majorly attributed to the fact that government opts for a ceiling policy and does not, amongst other things, avail adequate resources appropriate for public schools to also excel.

Factors such as lack of literature materials, teachers' poor motivation, lack of text books, and lack of interest, coupled with working in an unconducive environment, are some of the major factors to which poor performance could be partly attributed.

That this Motion be referred to the relevant Parliamentary Standing Committee for further scrutiny and report back to this House.

On the motion of Hon. Tjirare, seconded by Hon. Vries, debate adjourned until Tuesday, 5 March 2024.
