**The Directorate of Office of the Speaker** which covers my Office and that of the Deputy Speaker provided leadership

to the institution during this most difficult time in the history of our country and that of our institution. We provided guidance and direction on best possible ways to mitigate the effects of the COVID-19 pandemic and to ensure that the business of the National Assembly remained uninterrupted during that period. We engaged party leaders and chief whips to set the tone for new innovations on how best we could advance the concept of technology to ensure that the sessions and the work of the Assembly remain uninterrupted. We will continue to provide that leadership post – COVID 19 era to ensure our constitutional mandate is successfully executed. We have adopted rules that will enable the National Assembly and its committees to have virtual and hybrid sittings in case of such challenges beyond our control.

**The Division of Table Office** demonstrated exceptional agility in managing parliamentary sessions under the new norm, starting with the implementation of a decongestion plan in the Chambers, facilitating the tabling and passing of crucial bills, and adapting to virtual formats to ensure uninterrupted legislative processes.

The Division of Research, Information, Publications, and Editorial Services played a key role in disseminating information and facilitating dialogue and adapting strategies to ensure continuous engagement with the public in a largely virtual environment.

On the international front, talking about the technologically advanced world, during the peak of the COVID – 19 pandemic, we virtually participated in the 212<sup>th</sup> Session of the IPU Governing Council. What made this session unique was, that it was the first ever IPU Assembly to be convened virtually and we were able to vote online, for the first time the new IPU President. It was a sophisticated exercise but we managed it well and our votes were also counted at the end. The experience of the COVID – 19 pandemic taught us, that change is evident and with commitment we can venture into new avenues that can make our lives and work easier.

# **EXECUTIVE SUMMARY**

The objective of this annual report is to inform the public about the activities of the National Assembly for the financial year 2020/2021. Article 44 of the Namibian Constitution gives the National Assembly the legislative power to scrutinize and pass bills and refer them to the National Council for confirmation before they are sent to the President for assent.

### LAW MAKING

During the reporting period, 20 Bills were tabled in the National Assembly and 16 were passed without amendments after extensive debates. 3 Bills were withdrawn after being tabled, while one was reconsidered from the National Council.

## **OVERSIGHT AND ACCOUNTABILITY**

The mandate for the oversight function of the National Assembly is exercised through tabling of motions, questions, public hearings and parliamentary inquires. To this end, a total of 19 motions were tabled for discussions and three were adopted, 101 Auditor-General's Reports were tabled, a total of 14 reports of Standing Committees on local visits, meeting and public hearings were tabled, in addition, a total of 12 Standing Committee reports on foreign engagements were also tabled.

## **OUTREACH**

During the reporting period, the National Assembly as per its oversight mandate, held public hearings in Ohangwena, Oshana, Omusati, Oshikoto, Kunene, Zambezi, //Kharas, Hardap, Kavango West and Kavango East and Omaheke regions on four motions. The motions are on Old Age Homes in Namibia; on Gender-Based Violence; on Expanding Medical Clinics to all tertiary institutions in the country and on high incidences of suicides in Namibia. The National Assembly also conducted inspection visits to capital projects in all 14 regions of the country.

Under the theme "Know Your Parliament Programme", the National Assembly conducted public education campaigns for selected communities by attending trade fairs and visiting secondary schools.

## INTERNATIONAL/REGIONAL ENGAGEMENTS

Parliament, being a member of regional; continental as well as international parliamentary bodies, attended activities of the SADC-Parliamentary Forum (SADC-PF); Pan African Parliament (PAP) the Commonwealth Parliamentary Association (CPA) and the Inter-Parliamentary Union (IPU).

### PARLIAMENT SECRETARIAT

The Secretariat that consists of various offices, directorates and divisions provides administrative and professional services to the National Assembly. The duties and functions of the Secretariat form part of this report.





## OFFICE OF THE SPEAKER

#### **MANDATE**

The functions of the Speaker is provided for in the Namibian Constitution and in the Standing Rules and Orders of the National Assembly, among others, are as follows:

- · Presiding at sittings of the National Assembly, enforcing the Standing Rules and Orders; calling upon members who wish to speak and maintaining order in the House. In the process, ensuring the integrity, independence and impartiality of Parliament by emphasizing the importance and independence of Parliament.
- Ensuring appropriate support services for the National Assembly, smooth administration of the precincts of the National Assembly and the welfare of Members and Secretariat.
- · Representing the National Assembly in its relations with the executive and other authorities at official events and at international arenas of parliamentary multilateral organisations.
- · Hosting diplomatic and other foreign dignitaries and delegations, in promoting parliamentary bilateral relations and cooperation.

## SUPPORT STAFF TO THE PRESIDING OFFICERS

A number of staff members provide support services to the Speaker and the Deputy Speaker. The services range from secretarial to administrative, executive, technical and professional support.

## **CHALLENGES**

- Limited financial and human resources were the major challenges facing the directorate thus hampering the effective provision of efficient and effective services to the Speaker and the Deputy Speaker.
- The outbreak of the Covid-19 pandemic exposed the weakness of the IT infrastructure at the National Assembly which required a complete upgrade in order to host virtual meeting successfully.
- The absence of an independent parliamentary service commission to effectively address the staff recruitment and allocation continues to hamper the provision of effective and efficient service to the Speaker and the Deputy Speaker.



# OFFICE OF THE SECRETARY

#### **MANDATE**

The mandate of the Office of the Secretary is to account for the National Assembly's administration and to advise the Speaker, Deputy Speaker and Members of Parliament on matters pertaining to administration and procedures.

#### SUPPORT STAFF TO THE SECRETARY

Three staff members are employed directly under the Office of the Secretary. Two staff members provide direct support services to the Secretary. These support services range from secretarial to administrative and executive support. The third staff member is the internal auditor who falls under the sub-division Internal Auditor.

## **OPERATIONAL ACTIVITIES**

- · Responsible for the effective management and utilisation of human resourses of the National Assembly and provide guidance to the directorates.
- · Prepare the annual budget in consultation with the financial adviser and the management.
- · Attend sessions of the National Assembly and provide procedural advice to the Speaker, Presiding Members and Members.
- · Provide professional advice and support services to the Speaker when required, and;
- · Represent the National Assembly at various levels when engaging offices, ministries and agencies (OMAs) of the Namibian government and other stakeholders.

## **ACTIVITIES UNDERTAKEN**

- · From 8-11th July 2020 the secretary attended capacity building workshops on SRHR in Otjiwarongo.
- · From 15-21 November 2020 the secretary attended the workshop on the Amendmend of the Standing Rules and Orders in Swakompund

## SUB-DIVISION: INTERNAL AUDIT

#### **MANDATE**

The Internal audit's mandate includes monitoring, assessing, analysing organisational risk, and implementing internal controls and compliance with policies, procedures and regulations.

## **OPERATIONAL ACTIVITIES**

· Work in partnership with management, external auditors and the audit committee to ensure that risks are mitigated and that the National Assembly's positive image is maintained.



- · Produce audit reports which comprise of findings and recommendations necessary to enhance compliance with policies, procedures and regulations.
- · Verify existence of assets and ensure their safekeeping.
- · Ensure effectiveness and efficiency in the utilisation of resources.
- · Perform consulting and advisory services related to corporate governance, risk management and internal controls as deemed appropriate for the organisation.



# DIVISION SECURITY AND RISK MANAGEMENT SERVICES

## **MANDATE**

To render effective and consistent security services to the assets of the National Assembly.

#### **OPERATIONAL ARRANGEMENT**

The Division Security and Risk Management Services works closely with the Namibian Police to provide security service and response capability, with duties including, but not limited to:

- · Protecting the Parliament building so that parliamentarians and staff members of Parliament can carry out their legislative roles and duties in a safe and secured environment;
- Enforcing security measures including entry screening of personnel and their property when accessing National Assembly building;
- · Access control and monitoring as well as roving patrol around the precincts of Parliament;
- · Immediate response to security incidences around the precincts of Parliament among others.

## HIGHLIGHTS OF THE YEAR UNDER REVIEW

During the Financial Year under review, the following notable achievements were recorded:

- Physical security infrastructure was upgraded. A new baggage scanner, a walk-through metal detector and a number of CCTV cameras and screens were acquired for the safety of Parliament Building users and for effective monitoring of movements around Parliament precincts.
- The National Assembly in collaboration with co-located institutions, (National Council, OPM, MIRCO and MICT) with the assistance of the Ministry of Defence and Veterans' Affairs debushed a fire security threat area behind the Parliament building and the co-located institutions that had thick bushes growing into the buildings.
- · Rendered security service to the assets of the National Assembly when at the precincts of Parliament. This include Members of Parliament, staff members of parliament, visitors, stakeholders, services providers and property of parliament, among others.
- · Developed and consistently enforced security measures on the precincts of Parliament.
- · Coordinated and facilitated security arrangements when individuals, groups and/or institutions come to petition parliament.
- Coordinated and facilitated the accreditation and provision of identification access cards for Members of Parliament and staff members of parliament. The identification access cards are part of security requirement and measures that allows Members of Parliament and staff to access the parliament premises without a hassle.

## **CHALLENGES**

 The division is under-staffed (only one staff member in the division) and it is a challenge for one person to carry out all the required security coordination of the National Assembly.



## **TABLE OFFICE**



#### **MANDATE**

The division supports the National Assembly in attaining its objectives as enshrined in the Namibian Constitution (Article 63 – Functions and Powers). To do so, the following functions have to be performed:

- · Provide operational assistance and guidance to the National Assembly;
- · Provide logistical support and advise on procedural and other matters, and to see to it that the requirements of the Members of Parliament are attended to, so as to ensure the proper functioning of the National Assembly.
- · Liaise with legal drafters.
- · Ensure the timely printing of minutes, order papers, questions, bills and any bill amendments.
- · Communication and liaison with the National Council regarding the conduct of business between the two Houses, especially with regard to the referral of bills passed by the National Assembly for their consideration.
- · Preparation of bills for tabling in the Assembly.
- · Processing legislation passed by the Parliament to become Law.

# **SUB-DIVISION: COMPUTER SERVICES**

#### **MANDATE**

The Sub-Division Computer Services is responsible for the management and maintenance of the computer network at Parliament. The Computer Services is a common resource shared by the National Assembly and National Council and is responsible for the management and maintenance of the Parliament computer network and provision of technical user support services.

#### **OPERATIONAL ACTIVITIES**

Computer Services runs a helpdesk that provides end-user support to Members of Parliament and administrative staff. Computer Services maintains the parliamentary website, www. parliament.na, which provides direct access to information related to Parliament.

#### **ACTIVITIES UNDERTAKEN**

- · Procurement of 20 computers and printers for Members of Parliament as well as accessories to enable virtual meetings such as webcams and headphone set.
- · Completion of installation of conference audio/visual recording system in the National Assembly Chamber.
- · Continual Software licence support renewal and helpdesk support service
- Acquiring of 18 computers for MPs and two for the Secretariat at National Assembly and network accessories such as switches, LAN cables since most MPs share offices.
- · Webcam and microphone were also acquired in limited stock to enable some users to attend virtual meetings from their offices.
- · Training seminars were also arranged for all users who need help on conducting virtual meetings as well as how to access their official emails from outside the office and usage of WhatsApp as an official communication platform.
- The e-Parliament chamber system also makes it easier to overcome most challenges experienced during Covid-19 as well as;
- · Acquiring of tablets for MPs of the National Assembly.
- Therefore, Windows servers were successfully upgraded from 2012 to 2019 version and Exchange server is due for an upgrade from 2013-2019 as well. During upgrading, it was also an opportunity to rename

- · To embrace e-Parliament, more mobile device such as laptops and tablets/iPad are still needed
- · Lack of ICT policy makes it harder for staff member to be held service user accountable
- · IT structure needs to be expanded due to service/system growth
  - **o** Limited IT staff members to set up meetings and carry on with other administrative works.
  - o Insufficient equipment such computers, audio and video recordings.
  - o lack of knowledge among staff members and MPs on conducting virtual meetings.
- **Slow Procurement:** Although requests were made on time, most procurement action is taken once services are due for renewal and thus some downtime are experienced.
- Annual Maintenance: Suspension of scheduled annual maintenance affects statistical records for hardware/software performance indicators as no more proper planning is done to acquire new items.

# SUB-DIVISION: LIBRARY SERVICES \_

#### **MANDATE**

The sub-division Library Services is responsible for the provision of information services to legislators and the public.

# **OPERATIONAL ACTIVITIES**

The sub-division provides current and relevant legal information and research services to Members of Parliament and library users at large.

#### **ACTIVITIES UNDERTAKEN**

#### 1 BOOK STOCK

• The Parliament library received 139 legal deposit books and 20 legal deposit periodicals in 2021 from the National Library.

#### **BOOKS WEEDED**

• The library weeded 678 very old books from before 1990. This project took place between 2 and 10 September 2021 with the assistance of a Library Intern student.

#### LIBRARY USAGE

The usage of the library by the Members of Parliament decreased due to Covid-19 regulations.
 The library still remains closed to members of the public but researchers visited with prior appointments.

#### **E-SERVICES**

 In July 2021 the library received a mobile phone and is able to communicate the proceedings of the house through various social platforms.



- The usage of electronic parliamentary proceedings increased during this period because of the usage of the Parliament website, Facebook, e-mails, WhatsApp and Telegram services.
- · In addition, the library provides the e-New Era and e-Namibian newspapers to its users.

#### INTERNET USAGE

• The use of two computers available for internet usage by members of the public has decreased but increased for staff members.

#### **CURRENT AWARENESS SERVICES**

- · The library continues to promote the e-library service through the available social platforms.
- · Parliament library received a new update of NAMLEX database from the Legal Assistance Centre which empowered the library, especially during Covid-19, to provide its patrons timely and accurate electronic information such as Proclamations, Laws, Regulations, Statutes and Legislations, Gazettes, Pre-Independence Gazettes and Hansards.
- The e-New Era and e-Namibian newspapers were made available to Parliament library users.
- The library continually informed its users on new books via emails and display new books on the library displays located at the National Assembly Chamber entrance, Parliament library, and at the National Council which enhanced the increase in the library usage.
- The librarian's pick of the day from the newspaper clippings are displayed at the Parliament library entrance.
- The library scans parliamentary proceedings and makes them digital available to its users through Telegram, Parliament website, as well as through emails to the library patrons upon request.
- The usage of library computers by the library patrons, especially by the Members of Parliament for research and internet has increased but decreased for the public users.
- · Parliament library is a Member of NIWAN (National Information Workers Association of Namibia) and NIWAN hosted successfully the standing conference of Eastern, Central and Southern African Library and Information Associations from 8 to 11 February 2021, at Safari Hotel and Conference Centre in Windhoek. The librarian also presented a paper titled "Provision of relevant information by the Parliament library of Namibia to meet the information needs of Members of Namibian Parliament".

#### 4. CHALLENGES

- Staff members need training on the effective usage of the library database that is going through annual upgrades. The last training took place in 2015.
- · No books were purchased from 2019 to 2021.
- Annual membership fees for AFLIA, IFLA and APLESA has not been paid for 2019, 2020 and 2021.
- · Lack of space limits the shelving of new resources.
- The library is experiencing lack electronic books and e-journals, that are crucial in developing the e-library, due to budgetary constraints.



- · Budget cuts negatively affects the acquisition of library books needed by the core- users (MPs): on average a recommended book could cost above N\$300 for example, the book titled "The role of the highest courts of the United States of America and South Africa, and the European Court of Justice in Foreign Affairs cost N\$3 763.
- · As at the end of the financial year, the library lacked electronic books and e-journals.
- · Budget cuts affected the library's acquisition of new books, and periodicals.
- · A lack of space limited the shelving of new resources.
- The library needed to acquire additional e-books and e-Journals to develop its e-digital library.
