NOTICES OF MOTIONS

I. **Deputy Prime Minister and Minister of Works and Transport:**

That this Assembly –

In accordance with Article 112(3) of the Namibian Constitution;

Approve the appointment by His Excellency the President of Ms. Ludmilla Habbatte Doeses and Mr. Michael Mutonga as members of the Public Service Commission for a period of five years.

II. **Hon. Mootu:**

That this Assembly –

Discuss this motion that is calling on the expropriation of land of foreign absentee landlords without compensation in Namibia.

Cognizant of the property rights enshrined in Article 16 of the Namibian Constitution and Article 17 of the Universal Declaration of the Rights and Duties of Man; absentee landlords have benefitted for too long at the expense of native Namibians. The post-colonial government in its current state serves the growing interests of foreign nationals that reside outside, at the expense of those who have lost land as a result of land dispossession.

The National Resettlement Policy 2023 – 2033 tabled by Hon. Calle Schlettwein, Minister of Agriculture, Water and Land Reform demands that farmers should have an in-flow of up to 2 million to qualify for resettlement farm. This in its nature is an ultra-right policy that further perpetuates land inequality and benefits the political elites, disregarding the black majority.

Due to the demands of the criteria, the Landless People's Movement (LPM) proposes a truly transformative leftist approach to land distribution that prioritizes the empowerment of the masses.

This motion is aimed at ensuring that a critical national asset is not left idle or exploited by those who do not contribute to our nation's growth. The era of foreign exploitation is over, our land will be reclaimed for the benefit of our people.
