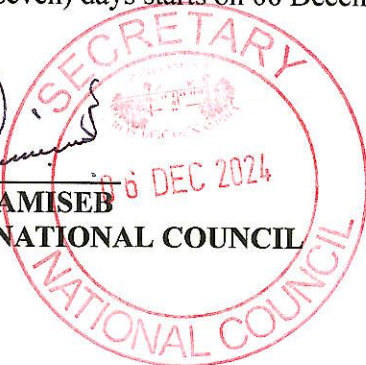
In the absence of an application for reconsideration, the Accounting Officer of the National Council will proceed with the award decision.

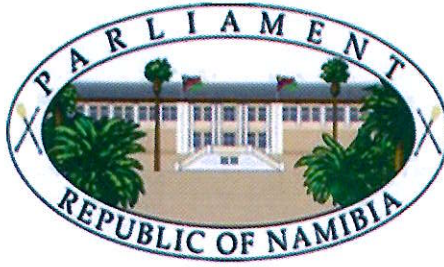
