# REPUBLIC OF NAMIBIA MINUTES OF PROCEEDINGS OF THE NATIONAL ASSEMBLY

### THURSDAY, 13 MARCH 2025

The Assembly met pursuant to the adjournment.

1. The Deputy Speaker took the Chair and read the Prayer and Affirmation.

#### 2. Hon. Hambyuka moved without Notice:

That the proceedings on the Order Paper of today, 13 March 2025, tomorrow Friday, 14 March 2025 and of Monday, 17 March 2025 be, in accordance with Rule (159) of the Standing Rules and Orders, not interrupted if today and Monday they are still under consideration at 17:45 and tomorrow Friday, at 12:30.

Agreed to.

## 3. **FIRST NOTICE OF A MOTION:**

The Minister of Agriculture, Water and Land Reform moved, seconded by Hon. Kavetuna:

That leave be given to introduce a Bill to provide the establishment of communal land boards and provide for their powers and functions; to provide for the establishment of the Communal Land Development Fund; to provide for the demarcation and extent of communal land areas; and the allocation of communal land rights; to provide for the powers and functions of chiefs, traditional authorities and land committees in the allocation of communal land rights; to provide for continuation of the Land Reform Advisory Commission; to provide for the continuation of the Land Acquisition and Development Fund; to provide for the acquisition of commercial agricultural land by the State for the purpose of land reform and for other land reform related purposes and for the allocation of such land to Namibian citizens who do not own or otherwise have the use of any or of adequate agricultural land; to vest in the State a preferential right to purchase commercial agricultural land; to provide for the compulsory acquisition and alienation of commercial agricultural land by the State for the purposes of land reform and other land reform related purposes; to prohibit the acquisition of commercial agricultural land by foreign nationals; to regulate the leasing of commercial agricultural land by foreign nationals; to provide for the valuation of commercial agricultural land; to provide for the continuation of the Valuation Court under the name Valuation Tribunal; to provide for the imposition of land tax; to provide for the continuation of the Lands Tribunal, to provide for the appointment of authorised officers to perform certain functions under the Act; and also to provide for incidental matters.

Agreed to.

Land Bill [2 - 2025] read a First Time.

The Minister of Agriculture, Water and Land Reform moved, subject to Rule 168(1) of the Standing Rules and Orders, seconded by Hon. Elago: That the Bill be read a Second Time.

On the motion of the Deputy Minister of Finance and Public Enterprises, seconded by Hon. Ithete, debate adjourned until Wednesday, 19 March 2025.

### 4. SECOND NOTICE OF A MOTION:

The Minister of Finance and Public Enterprises moved, seconded by the Deputy Minister of Works and Transport:

That leave be given to introduce a Bill to amend the Public Procurement Act, 2015; so as to establish the public procurement court; to make provision for the jurisdiction of the public procurement court; to provide for administrative and procedural rules that govern the conduct of public procurement hearings, and to provide for incidental matters.

Agreed to.

Public Procurement Amendment Bill [B. 3-2025] read a First Time.

The Minister of Finance and Public Enterprises moved, subject to Rule 168(1) of the Standing Rules and Orders, seconded by the Minister of Defence and Veterans Affairs: That the Bill be read a Second Time.

On the motion of Minister of Finance and Public Enterprises, seconded by Hon. Dingara, debate adjourned until Friday, 14 March 2025.

### 5. **FIRST ORDER READ:**

Resumption of Debate on Second Reading – Judiciary Amendment Bill [B. 1 – 2025].

Question before the Assembly on Wednesday, 12 March 2025, as moved by the Minister of Justice (page 40).

Question put: That the Bill be read a Second Time.

Agreed to.

Judiciary Amendment Bill [B. 1 – 2025] read a Second Time.
