# REPUBLIC OF NAMIBIA MINUTES OF PROCEEDINGS OF THE NATIONAL ASSEMBLY

## WEDNESDAY, 16 APRIL 2025

The Assembly met pursuant to the adjournment.

1. The Deputy Speaker took the Chair and read the Prayer and Affirmation.

# 2. Announcements by the Deputy Speaker in terms of Rule 117(b) of the Standing Rules and Orders:

(i) Firstly, The Deputy Speaker brought to the attention of the House that in terms of Rule 67 of the Standing Rules and Orders, all Members of the Assembly, upon being sworn in as Members, must declare their financial interest as required in this Code of Conduct and are obliged to adopt the principles of the Code by signing the Declaration of Members' Financial Interests.

He continued to state that, subject to **Rule 65** of the Standing Rules and Orders, the first declaration must be made within 30 days of being sworn in as a Member of Parliament and therefore alerted the Members that the distributed forms be submitted to the Acting Secretary's Office on or before Wednesday, 30 April 2025.

In the same vein, the Deputy Speaker informed that House that it is also important to note that, as per **Rule 67(4)**: After the first declaration, Members must annually declare particulars of their registrable interest on or before 30 April each year.

(ii) Secondly, the Deputy Speaker informed the House that on a very sad note, we came to learn about the passing of Ms. Rebekka Mathias, a niece of Hon. Festus Thomas, during the past weekend. The House wished Hon. Thomas and his entire family their heartfelt condolences and all the strength to overcome their loss. (iii) Lastly, the Deputy Speaker shared with the House that in the meeting held on Tuesday, 15 April 2025 with the Chief Whips of the different political parties, it was proposed that the House to sits from 09:00 to 12:30 on Thursday, 17 April 2025 to accommodate the Members who are planning to travel for the long weekend.

The House agreed.
