# REPUBLIC OF NAMIBIA MINUTES OF PROCEEDINGS OF THE

# NATIONAL ASSEMBLY

**TUESDAY, 29 APRIL 2025** 

The Assembly met pursuant to the adjournment.

- 1. The Deputy Speaker took the Chair and read the Prayer and Affirmation.
- 2. Announcement by the Deputy Speaker in terms of Rule 117(b) of the Standing Rules and Orders:

The Deputy Speaker announced that the National Assembly shall proceed to elect the Deputy Chairpersons of the Whole House in terms of Rule 32 read with Rule 28 of the Standing Rules and Orders:

## **Election of the Deputy Chairpersons of the Whole House:**

In terms of Rule 32(1) of the Standing Rules and Orders, Hon. Kröhne, seconded by Hon. Amutse, nominated Hon. Herunga, and Hon. April, seconded by Hon. Werner lita, nominated Hon. Kooper, to be the Deputy Chairpersons of the Whole House of the National Assembly. The nominees accepted their nominations.

No additional nominations were proposed by the House and as a result the Deputy Speaker declared Hon. Herunga and Hon. Kooper as the duly elected Deputy Chairpersons of the Whole House of the National Assembly, in terms of Rule 28(2) of the Standing Rules and Orders.

# For discussion and adoption:

- Vote 03 National Assembly: Discussed, but deferred to the next sitting to allow consultations.
- Vote 11 National Council: Deferred to the next sitting to allow consultations.
- Vote 28 Electoral Commission of Namibia: Discussed and agreed to.
- Vote 30 Anti-Corruption Commission: Discussed and agreed to.

## ASSEMBLY RESUMED:

Progress reported and leave granted to sit again.
