# REPUBLIC OF NAMIBIA MINUTES OF PROCEEDINGS OF THE NATIONAL ASSEMBLY

### THURSDAY, 3 JULY 2025

The Assembly met pursuant to the adjournment.

- 1. The Speaker took the Chair and read the Prayer and Affirmation.
- 2. Announcements by the Speaker in terms of Rule 117(b) of the Standing Rules and Orders:
  - (i) The Speaker acknowledge the presence of a delegation of visitors from the Republic of Cameroon in the Gallery, and they include lawyers, public servants, local authority employees, academics, medical doctors, United Nations employees and entrepreneurs.
    - The Speaker reported that the delegates are visiting Namibia for the first time and they are sending their well wishes to all the Parliamentarians.
    - The Speaker welcomed them to Namibia and expressed her hope that they will enjoy their visit.

### 3. Message from the Head of State in terms of Rule 117(c) of the Standing Rules and Orders:

The Right Hon. Prime Minister delivered a message from the President on the premise of rendering quality service to improve the living standards of all Namibians.

Since the inauguration of the Government on 21 March this year, the Government has moved at a supersonic speed to implement impactful programmes that improve the livelihoods of the Namibian people, among them free tertiary education for all students come 2026. This year, all Green Schemes will operate at 100 per cent capacity by planting all the hectares in order to improve food security in the country. In addition, the Government will introduce agro-processing facilities in all 14 regions with at least three (3) to come on board this year in Omusati, Kavango East and Hardap Regions. Through these programmes, Government will be able to create hundreds of job opportunities for unemployed Namibians.
