FIRST SESSION, EIGHTH PARLIAMENT

REPUBLIC OF NAMIBIA MINUTES OF PROCEEDINGS OF THE NATIONAL ASSEMBLY

WEDNESDAY, 9 JULY 2025

The Assembly met pursuant to the adjournment.

1. The Deputy Speaker took the Chair and read the Prayer and Affirmation.
