# NATIONAL ASSEMBLY

#### **THURSDAY, 2 OCTOBER 2025**

The Assembly met pursuant to the adjournment.

- 1. The Deputy Speaker took the Chair and read the Prayer and Affirmation.

A Petition by the Landless People's Movement (LPM), seeking to request the Speaker to urgently disengage from conduct that is contrary to the intent of Parliament in respect of the search for Genocide, Apology and Reparations.

The Deputy Speaker reported that the Petition is going to be referred to the Standing Committee on Constitutional and Legal Affairs and Petitions as established under the Committee Rule 34(4), for investigation and report back to this Assembly.

This appointment is effective from 1 October 2025 for a period of six months, and shall remain in force until 31 March 2026, or until such time as a substantive Board is duly appointed in line with the Act, whichever comes first.
